Club Overview

Founded in 1883, Bristol Rovers Football Club (BRFC) is the oldest professional football club in Bristol, England. The club's official nickname is "The Pirates", reflecting the maritime history of Bristol.

The Football Club Safety Stewards Supervisor is responsible for overseeing the operations during matches, managing stewards, ensuring compliance with health and safety regulations, and creating a positive environment for spectators. This role requires strong leadership skills, excellent communication, and a passion for football.

Key Responsibilities/Criteria

- Will have or be willing to work toward the Level 3 NVQ in spectator safety.
- Willing to complete additional training as required by BRFC.
- Previous experience in leading a team would be advantageous.
- To attend pre-event planning and briefing sessions.
- To control and coordinate Stewarding and safety in specific stands on match days.
- To ensure that the requirements of the Safety Certificate and ground regulations are always met.
- To always be responsible for the safety and comfort of spectators within a designated area.
- To assist with the training and development of Stewards.
- To ensure all safety checks are carried out and report back to the Control room.
- To monitor all Stewards in designated area before, during and after the event.
- To Attend pre-match and post-match briefings and compile a concise report for Safety Officer.
- To carry out all instructions given by the Safety Officer/Deputy Safety Officer.
- Liaise with other Supervisors before, during and after each event.
- Allocate Stewards for specific roles and responsibilities.
- To brief all Stewards in your designated area and debrief them after the event.
- To collect and report any information from the event back to the Safety Officers.
- To ensure all Stewards are aware of the date and time of the next event/match.
